| What is the overall <a href="#">deductible</a> ?                                | \$2,700 Individual/ \$5,400 Family   | Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this plan begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .   |
| Are there services covered before you meet your <a href="#">deductible</a> ?    | Yes. Preventive care, inpatient facility and outpatient surgery are covered before you meet your deductible.   | This <a href="#">plan</a> covers some items and services even if you haven’t yet met the <a href="#">deductible</a> amount, but a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply.  |
| Are there other <a href="#">deductibles</a> for specific services?              | No.  | You don’t have to meet <a href="#">deductibles</a> for specific services.  |

If you have other family members in this plan, they have to meet their own <a href="#">out-of-pocket limits</a> until the overall family <a href="#">out-of-pocket</a> limit has been met.   |
| What is not included in the <a href="#">out-of-pocket limit</a> ?               | Employee premiums, balance-billed charges and healthcare this plan doesn’t cover.  | Even though you pay these expenses, they don’t count toward the <a href="#">out-of-pocket limit</a> .  |
| Will you pay less if you use a <a href="#">network provider</a> ?               | Yes. See <a href="http://www.ufcwnationalfund.org">www.ufcwnationalfund.org</a> or call 201-569-8801 for a list of <a href="#">network providers</a> . | This <a href="#">plan</a> uses a <a href="#">provider network</a> . You will pay less if you use a <a href="#">provider</a> in the <a href="#">plan’s network</a> . You will pay the most if you use an <a href="#">out-of-network provider</a> , and you might receive a bill from a <a href="#">provider</a> for the difference between the <a href="#">provider’s</a> charge and what your <a href="#">plan</a> pays (balance billing). Be aware, you <a href="#">network provider</a> might use an <a href="#">out-of-network provider</a> for some services (such as lab work). | Do you need a <a href="#">referral</a> to see a <a href="#">specialist</a> ?    | No.  | You can see the <a href="#">specialist</a> you choose without a <a href="#">referral</a> .   |

**Does this plan provide Minimum Essential Coverage? Yes**

If you are eligible for certain types of [Minimum Essential Coverage](#), you may not be eligible for the [premium tax credit](#).

**Does this plan meet the Minimum Value Standards? Yes**
