What is the overall deductible?	For network providers only: \$1,000	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
Are there services covered before you meet your deductible?	Yes. Preventive care, inpatient services, and outpatient surgery are covered before you meet your deductible.
